## First Outgrower Purchases

## **Outgrower Support Program**

KVTC has been supporting smallholder farmers in growing teak trees and diversifying their income streams through the Outgrower Support Program. KVTC currently supports approximately 350 farmers who have planted close to 1,000ha of teak since 2011.

In previous years the company has not bought any teak trees from external growers but it is proud to announce that from this year it has started doing so. In this article, we are sharing some of the experiences of two of the growers:

## Mr Michael Masikini

Michael Masikini was the first person ever to sell teak logs to KVTC's Mavimba Sawmill. Mr Masikini indicates that he has been looking for opportunities to realize a return on his teak trees. When he heard that KVTC has started buying logs he confesses that he felt that finally his dream would come through and that the money received for his trees will assist him in building a house that in turn he can rent out to people working at the sawmills where the trees are going. Mr Masikini thanks KVTC for starting this project of buying logs

from external sources as the KVTC price structure is much better than other buyers.

## Mrs Juslin Joseph

Mrs Joseph is living in Mikese-Morogoro with her five children of which four are schooling. School fees were a serious challenge for Mrs Joseph and the only asset she had was a plot of trees in Kidagalo Village. When Mrs Joseph was informed that KVTC had started buying trees from outgrowers she did not hesitate and she saw the opportunity to raise money for her children's school fees. Mrs Joseph visited the KVTC offices and sold her trees on the 9th of August.

We hope the recent purchases will benefit Mrs Joseph's and Mr Masikini's families and we like to thank them for working together with KVTC. We also hope they will continue planting more trees and hope we will buy more from them in future.

## **Annual Village Seminar**

On 24th of May 2017 KVTC conducted its Annual Village Seminar. About 100 representatives of seventeen villages and wards as well as officials from the Kilombero, Ulanga and Malinyi District attended. The meeting was chaired by the Kilombero District District Commissioner, Hon. James Ihunyo.

The Kilombero District Commissioner Hon. Ihunyo called on investors to ensure social projects established are sustainable.

The District Commissioners of Ulanga, Malinyi and Kilombero commended KVTC for the benefits it has provided to local people. The establishment of a factory in Ulanga has provided employment opportunities to many young people in these districts said Hon. Ihunyo

# KVTC Contributions to the Economy

At the meeting KVTC management shared statistics on the contributions to local and national development. In the year 2016 KVTC spent about 6bn TZS on local contractors, 1.7bn TZS in local and national taxes as well as almost 0.5bn TZS on the OSP Program.

Apart from the councils benefiting from tax paid by the company, the DC advised the management to ensure transparency by sharing information with district authorities on investment matters, planting of teak trees, harvesting and ways council can benefit more from them.

## 2016 Social Fund and Village Bonus

The district commissioner handed over the 2016 social fund bank payment confirmation slip and village bonus payment total worth 81 million shillings. The social fund has been instrument al in supporting and implementing community projects and as a source of cofinance for larger village or joint venture projects.
